## **SECTION 4: FIRST AID MEASURES**

### Description of First Aid Measures

## **SECTION 5: FIRE-FIGHTING MEASURES**

### **Extinguishing Media**

**Suitable Extinguishing Media:** Use extinguishing media appropriate for surrounding fire.

Withdraw immediately from the area if there is a rising sound from a venting safety device or discoloration of vessels, tanks, or pipelines. Be aware that burning liquid will float on water. Notify appropriate authorities if liquid enter sewers or waterways.

**Hazardous Combustion Products:** Carbon oxides (CO, CO<sub>2</sub>). On heating: release of toxic and corrosive gases/vapors sulphur oxides.

### **Methods and Material for Containment and Cleaning Up**

**For Containment:** Contain any spills with dikes or absorbents to prevent migration and entry into sewers or streams.

**Methods for Cleaning Up:** Ventilate area. Small quantities of liquid spill: take up in non-combustible absorbent material and shovel into container for disposal. Collect absorbed material and place into a sealed, labelled container for proper disposal. Practice good housekeeping - spillage can be slippery on smooth surface either wet or dry. Liquid spill: neutralize with powdered limestone or sodium bicarbonate.

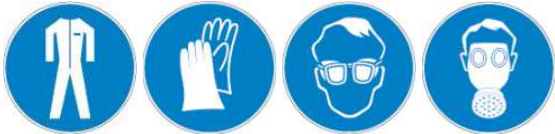

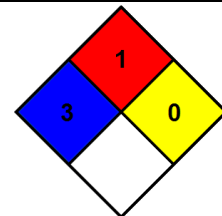
