SECTION 3. COMPOSITION/INFORMATION ON INGREDIENTS

SECTION 6. ACCIDENTAL RELEASE MEASURES

- 6.1 SPILL AND LEAK RESPONSE AND ENVIRONMENTAL PRECAUTIONS: Uncontrolled releases should be responded to by trained personnel using pre-planned procedures. No action shall be taken involving personal risk without suitable training. Keep unnecessary and unprotected personnel from entering spill area. Do not touch or walk through material. Avoid breathing vapor or mist. Provide adequate ventilation. Proper protective equipment should be used. 7.3 NONBULK: CONTAINERS:

Store containers in a cool, dry location, away from direct sunlight, sources of intense heat, or where freezing is possible.
